#### FROM THE REAR COMMODORE



*November* ~ *time for giving thanks*! I want to express my thanks for our Member volunteers who continue to serve our Club on the Monday Morning BBQ and Maintenance Crews.

No amount of home baked cookies, French roast, coffee cakes or pink boxes from the Donut Master can express my appreciation for their efforts. Our Wednesday Night Grill and Friday Night Burger potluck dinners are only made possible by their volunteer hours. Ted & Paula Mihok, Mark Casteel, Ferd Johns, Ed Crelly, Steve Williams, David Flomerfelt; and others including: Mike White, Bruce Brown, Bob & Bobby Greathead, Bill Coltrin and 'Dutch' ~ all are deserving of our sincerest gratitude for their expert handiwork, time and talent. Their generosity and dedicated volunteer hours make a significant contribution to the operation and financial well-being of the Oak Harbor Yacht Club! And all of this happens with smiles and a fun spirit of camaraderie!

If you are looking for a great way to get involved, have fun and contribute to our Club, join us on Monday mornings at 9am on the patio. It's always time well spent by the water. Dress is casual. You can even bring your dog. We get the work done and then party-on with coffee and pastries. New volunteers are most welcome and encouraged to join the 2017 Crew!

Recent and current Maintenance Projects include:

Working on securing bids for the insulation in the ceiling. Expected cost is \$500 - \$800.

Gas range service and repair in the upstairs galley ~ Done!

Thermostats have not been working, and ovens have not been heating evenly. We found that two of the burners were not properly attached. Gene at Ambient Appliance Repair of Mt. Vernon was highly recommended by Dick's Restaurant Supply and Broadview Appliance in Oak Harbor as their top pick for service and repair of our gas range. On October 19, Gene completed a very thorough cleaning of all the working parts, made critical adjustments, calibrations, and left our commercial gas range in working order. He also inspected our commercial dishwasher. It is cleaning and sanitizing our dishes at the proper temperatures as it should. In his opinion, our appliances are older, but of good quality, and, with proper maintenance, we can expect them to continue to serve our Club well for years to come. Having our large gas range in good working repair is critical going into the holiday season.

The sewer vault alarm has been problematic over the past two months. We have had to silence the audio alarm several times recently as the float levels in the tank rose to full levels. The sewer vault is not a septic tank, but does require regular pump out and annual service. Silvia Septic service made an inspection three weeks ago and advised a pump out and pressure wash. They also advised us that the two pump system was not working correctly, causing the tank to fill and setting off the loud outdoor alarm, audible clear over to Bay Shore Park. One pump is not working, and the metal structure that holds the floats and pumps and cover is badly rusted. Silvia Septic pumped and washed the vault and thereupon advised us that the pump could not be pulled out for service or replacement without the metal support rails failing. They advised us to replace and or repair the failing pump and interior metal structure, rails and tank lid.

We are on a list for service needed at this time, and I will report on the assessment and cost for repairs as soon as possible. We are fine for now with one pump operating in the cleaned vault until we can get the second pump serviced. We are monitoring the system continuously.

The grease traps in the galley upstairs are also due for cleaning and this needs to be done annually. We have a Maintenance Maestro who has volunteered to do the dirty deed and we will take him up on his very kind offer to assist. This will help to keep the sewer vault free of sticky build-up as well.

This week, David Flomerfelt fixed the upstairs fire door weather stripping at the bottom of the door. This project included removing the door, and refitting the weather strip with adhesive and screws. Thank you David!

Challenges always come with change, but again, your Commodores embrace these challenges as opportunities and we are very optimistic and excited for 2017.

<u>Halloween</u> falls on a Monday this year – so what better way to spend <u>Monday Night Football than</u> in costume? Dress up for the fun and the football.





If you would like to vote by mail, please print the ballot sent to you digitally (print pages 10-12) and return it in a sealed envelope marked with the word "Ballot" on the envelope. Place that envelope in another envelope with your name on it. Our Club Manager or Bartender will record the sender's name without opening the envelope and store the sealed ballots at the club until the night of the Elections Dinner at which time they will be counted.

#### Vote in person before the Elections Dinner:

If you are unable to attend the Elections Dinner and would like to vote prior to that time, ballots will be available at the club. When you ask for a ballot at the bar, your name will be recorded and your confidential, completed ballot will be stored in a ballot box at the club until the evening of the Elections Dinner, when it will be counted.

#### Vote at the Elections Dinner:

The dinner is \$7.50 and tickets will be available at the bar around the 1st of November. Prior to the dinner, a table will be set up to issue you your ballot. Ballot boxes will be provided; your name will be crossed off the list and the results will be announced after the dinner.

Under the duties of the Commodore:

"Arrange for an annual audit or financial review of the Club's financial records by a certified audit firm, subject to approval by the Board."

Reason: Allows for the club to conduct an internal audit on a regular basis without the cost of an outside firm.

#### 10. Current Wording:

**Under duties of the Treasurer:** 

Article V, Section 6 – item (a) currently states:

Current: Maintain all financial records and accounts of the Club and be a signatory on Club accounts. "The Treasurer shall enter data and make changes to the Club account system. This duty is shared with the Commodore, Vice Commodore and Assistant Treasurer."

#### **Revised:**

"Maintain all financial records and accounts of the Club and be a signatory on Club accounts. The Treasurer and Assistant Treasurer shall enter data and make changes to the Club account system. The signatory duties of the Treasurers are shared with the Commodore, Vice Commodore, Rear Commodore, " (Continued on next page)

The current language allows signature authority to only the Treasurer. To bring clarity to the bylaw and meet our current standard business practices. This clarifies the duties as being shared with all Commodores. Any check over \$1,000 is signed by two and sometimes two of the four are gone.

FCC Rules, Licenses and Radio Frequency Plan


**Radiotelephone Operating Procedures**
